#### DETAILS OF PROPOSED PLAN OF WORK


The well will be killed by pumping oil into the tubing. It is then proposed to repair the producing White Line Section by placing approximately 1000 gallons of commercial Hydrochloric Acid Solution in the bottom of the hole. The well will then be shut in for about 72 hours before it is placed back on production.

This well was treated with 1000 gallons of commercial Hydrochloric Acid Solution Feb. 4, 1934, and with 1500 gallons Feb. 18, 1934. The results are not satisfactory. A Robinson canvas anchor packer has been set at 4090' and it is recommended that a third treatment using 1000 gallons of Hydrochloric Acid Solution be made below the packer.
