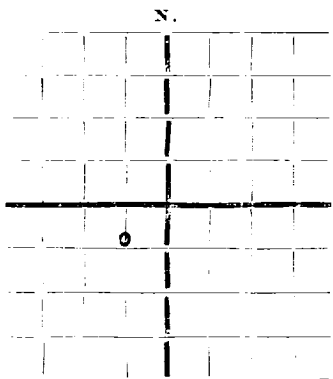

If changes in the proposed plan are considered advisable a copy of this notice showing such changes will be returned to the sender. Submit this notice in triplicate. One copy will be returned following approval.

If changes in the above plan become advisable we will notify you before cementing or landing casing. We estimate that the first productive oil or gas sand should occur at a depth of about **3100'** feet.

Additional information:

We expect to encounter a pay around 3100' as in the Humble Bower's #1 but will go down to the Midwest Discovery horizon. We may possibly run a short string of 16" - 65# casing in addition to above mentioned.
