Total depth 3133' Anhydrite and lime. Bar 90 joints of 5 1/2" CD 14 1/2" J-55 casing, 3174' set at 3100' and cemented with 400 sacks. Run down at 11:00 . . . 2-8-48. Cement was allowed to set 36 hours, plug drilled out, 1000' pressure applied with no drop in pressure. Drilling resumed.
