FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to plug and abandon Berry No. 8 in the Bowers Field as following:

- (1) Load hole with mud
- (2) Set 10 sack cement plug in shoe of 4-1/2" casing at approximately 3100'
- (3) Shoot off casing at approximately 1500'
- (4) Pull recoverable casing and set 10 sack cement plug in shoe of 8-5/8" casing at 420'
- (5) Set 10 sack cement plug in top of 8-5/8" casing at surface
- (6) Erect 4" marker as required by Rule 202
