Well was treated with 1000 gallons of 50 percent Hydrochloric Acid solution and the following results obtained:

Potential before acidizing; 6,377 barrels with a gas-oil ratio of 12,434 cu. ft.

Potential after acidizing : 6,377 barrels with a gas-oil ratio of 20,000 cu. ft.

(No potential increase was obtained after acidizing, but a large increase in gas was had) (Well is now shut in)
