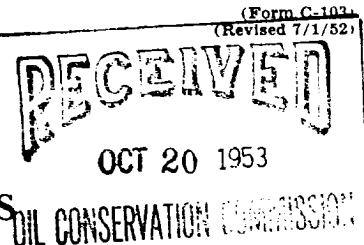

7" - 850#

Since the 9-5/8" pressure exhausted with no drop in 7" pressure, there is no communication between 7" and 9-5/8" strings.
