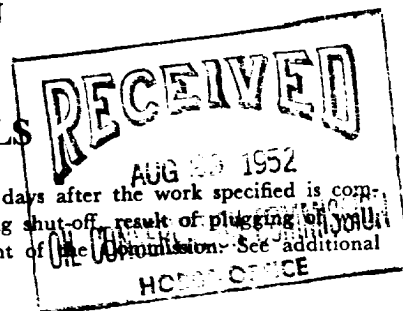

Completed 25th after cleaning out and installing pumping equipment.
Cleaned out from 3213' to 3256'. Set Lufkin T6D-9B Twin crank pumping unit powered w/5 HP GE motor.

Initial pumped 16 oil no water thru 2-3/8" tubing in 8 hrs ending 25th. and pumped off. Will be considered as 24 hr potential. 24 hr gas volume 16,900 cu.ft. GOR 1056/1. Allowable 16 bbls exempt. Daily average production before workover 3 oil no water for July, 1952. Allowable before workover 10 bbls exempt.
