## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Total depth 4175' Lime. Killed well with water and followed up W/341 sacks Bentonite and 25 sacks Jel Flake, 2 sacks Fibertex. Fished out 3" tubing. Cleaned well out, ran 133 joints of 2-3/8" tubing set @ 4144'. Packer set @ 3844'. Tested 7" casing and packer W/500# pressure for 30 min. Test OK. Ran swab, well started flowing, cleaned up 2%. On 24 hr. test well flowed 139 bbls. oil. GOR 604:1, Gty. 36 @ 60. Completed, final report.
