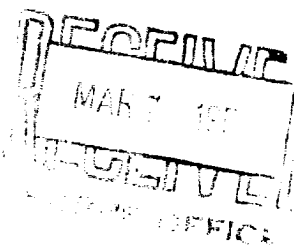

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was deepened from 4192' to 4235'. 375' of 5" OD steel liner was set on bottom at 4235' and cemented with 50 sacks. Liner was perforated at 4198-4204', and 4212-4228' with 88 holes and recompleted for initial potential of 660 bbls. oil, no water daily, based on a 6 hour test of 165 bbls. of oil, flowing through 3/4" choke on 2" tubing with GOR of 2590%.
