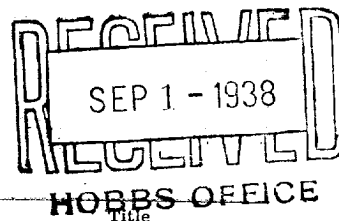

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Halliburton Cementing Process pumped 14 barrels, consisting of 5 sacks aquagel, 1 2/3 bales Fibretex and 50# cotton seed hulls; this mixture followed with 21 barrels water, in an attempt to seal packer.

Flowed 55 bbls. oil, no water 24 hours thru bottom hole choke. gas 1,605,000 cu. ft. No change in oil or gas after attempting to seal packer.
