DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On June 20, 1949 at 8:00 a.m., 36 hours had elapsed since running 329' of 9-5/8" casing set at 338', and cemented w/250 sacks. At this time pipe and water shut off was tested by applying 1000 psi pressure before and after drilling plug. Pressure did not drop in excess of 100 psi on either test. Drilling operations were resumed.
