## FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

On December 27, 1949, at 2:30 a.m., 48 hours will have elapsed since running 3142' of 5-1/2" casing set at 3128' and cemented with 800 sacks to be used as oil string. Cement was circulated to surface.

Pipe and water shut off will be tested by applying 1000 psi pressure and holding for 30 minutes before and after drilling cement plug. If pressure drop in excess of 100 psi occurs on either test proper remedial measures will be carried out. If tests are satisfactory drilling will be resumed.
