Repair of 8-5/8" casing June 1948 by circulating cement to surface behind 8-5/8" and running of new oil string, precludes possibility of pressure on annular space or leaks.

Plan to bleed off casing pressure and refill annular space between tubing and 8-5/8" with packer sealing material and treated oil to prevent corrosion.
