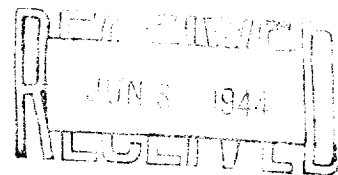

Set 4150 feet, 5 $\frac{1}{2}$ , 14 lb., J55 Casing, cemented with 350 sacks of El Toro cement, using 200 lbs of Calcium Chloride in last 100 sacks, on June 3, 1944.

Tested above casing on June 5th, 1944. with 800 lb pressure one hour. Test O.K.
