5-27-55 Ran in 2" tubing to 3500 ft. and placed 25 sx. cement plug at 3300 ft. - 3500 ft.
Shot off 5 1/2" csg. @ 2800 ft. but could not pull.

5-28-55 Shot off 5 1/2" csg. at 985 ft. but could not pull.
Shot off 5 1/2" csg. at 931 ft and pulled same.
Placed 5 sx. cement plug in top of 7-5/8" csg. with 1/4 inch pipe marker 1/4 ft. above ground.

Form C-103 filed 6-15-54 gives additional plugging details for this well.
