3. Cut 5 1/2" csg. @ 4025' w/ jet cutter but could not pull.
4. Cut 5 1/2" @ 2047' but still could not pull.
5. Run 2 3/8" tbg. to 2047' & spotted 38 sx. cmt. plug. POH w/ tbg.
6. Cut 5 1/2" @ 1538' & could not pull.
7. Cut 5 1/2" @ 1075' pulled and laid down 5 1/2"
8. Run 2 3/8" tbg to 1100' spotted 38 sx. cmt. plug.
9. Pull tbg. to 375' & spotted 38 sx. cmt. plug. POH w/ tbg.
10. Spot 10 sx. cmt. plug in top of surface pipe.
11. Install dry hole marker & clean location. move off unit.
