DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Drilled well to 4461'. Ran 131 joints, 4459.06', 7" OD casing set 4460'. Cemented with 625 sacks 8% gel, 100 sacks 4% gel, Trinity Portland regular cement. Pumped plug to 4429'. Pipe rotated throughout job. Top of cement 1850'. Tested casing with 1000# for 30 minutes before and after drilling plug. No pressure loss.
