FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pump 300 lbs. of Visco 900 mixed in 10 barrels of water and 5 gallons visco 1111 down the casing-tubing annulus and squeeze into formation with 180 barrels lease crude. (This would leave top of chemical at approximately 4400')
2. Shut well in and let it set for 24 hours.
3. Place well on production for 5 days. (To allow the recovery of chemical residue).
4. Pour 100 pounds Visco C5S crystals (Controlled Solubility Phosphates) down the casing tubing annulus.
5. Return well to production and run phosphate counts every 2 weeks until count drops below 10 ppm.
