2. Cut 2 7/8" csg. at 3000'. Break circulation thru 2 7/8" csg. & spot 50 sx. cmt plug top of stub.
3. POH with 2 7/8" & spot 50 sx cmt plug base of 8 5/8" from 1890 - 1760 ft.
4. Lay down remaining 2 7/8".
5. Spot 10 sx cmt plug in surface of 8 5/8".
6. Install dry hole marker & clean location.
