T.D. 4281' Lime, PBTD 4180'. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit, ND WH and NU BOP.
2. RU Halliburton and establish an injectection rate into Perfs @ 4179 - 4249' and cement squeeze Grayburg-San Andres Perfs @ 4179 - 4249' w/200 sacks of Class H w/3% CaCl₂ cement.
3. RIH w/chemical cutter and cut tubing @ 4015' and dump 23 sacks (410') of cement on top of a packer set @ 4038' to 3628'. Pull tubing to + 3500' and reverse out any excess cement. Circulate hole w/mud laden fluid. POOH w/tubing.
4. Perforate 4 squeeze holes @ + 2700'. RIH w/cement retainer on 2-3/8" tubing and set retainer @ + 2600'. Squeeze the Base of the Salt Section thru Perfs @ + 2700' w/300 sacks of Class C w/3% CaCl₂ cement. PO of retainer set @ + 2600' and dump 20 sacks (200') on top of retainer @ + 2600 - 2400'. POOH w/tubing.
- done 5/17/79 ~~5. Perforate 4 squeeze holes @ 1265'. RIH w/cement retainer on 2-3/8" tubing and set retainer @ + 1165' and squeeze thru squeeze holes @ + 1265' w/100 sacks of Class C w/3% CaCl cement. PO of retainer and POOH to 300'.~~
6. Spot a 30 sack (300') cement surface plug @ 300 - surface. POOH w/tubing.
7. ND BOP's, cut off WH and install a 4" dry hole marker to designate a plugged and abandoned location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
