O.T.D. 4281' Lime, PBD 4180'. It is proposed to plug and abandon this well in the following manner:

1. MIRU a pulling unit, ND WH, NU BOP and POOH w/tubing and packer.
2. RIH w/RB on tubing and CO to 4150', CHC and POOH w/RB and tubing.
3. RIH w/cement retainer on tubing and set retainer @ + 4100'. Establish injection rate into Perfs @ 4197 - 4249' and cement squeeze Grayburg-San Andres Perfs @ 4197 - 4249' w/150 sacks of Class C cement w/3% CaCl₂. PO of retainer and dump 23 sacks (410') of cement on top of retainer. POOH to + 3500' and reverse out any excess cement and load hole w/mud laden fluid. POOH w/tubing.
4. Perforate 4 squeeze holes @ + 2700'. RIH w/cement retainer on 2-3/8" tubing and set retainer @ + 2600'. Squeeze the Base of the Salt Section thru squeeze Perfs @ + 2700' w/300 sacks of Class C cement w/3% CaCl₂. PO of retainer and dump 20 sacks (200') on top of retainer. POOH to 1300'.
- * 5. Spot a 40 sack (400') cement plug @ 1300 - 900'. POOH to 300'.
6. Spot a 30 sack (300') surface plug @ 300 - surface. POOH w/tubing.
7. ND BOP's, cut off WH and install a 4" dry hole marker to designate a plugged and abandoned location.

* Need cmt. plug at least 1265'-1165' in & behind 5 1/2" casing.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
