2. Set **30** sx cement plug top Queen (4500-4610')
3. Set **30** sx cement plug base salt (3150-3220')
4. Set **30** sx cement plug top salt **1900'**
5. Set **30** sx cement plug in and out of bottom of surface pipe (250')
6. Set 10 sx cement plug at surface & put in 4" steel marker with necessary data:
Bob L. Johnson Gulf-State #1, Ne/4 NE/4 Sec. 26, T-18S, R-34E, Lea County,
New Mexico.
7. Drilling mud to be placed between all plugs
