

FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

The subject well is presently flowing a daily penalized allowable of 13 barrels oil with a gas-oil ratio of 11,979 cubic feet per barrel.

In accordance with the directive issued by the New Mexico Oil Conservation Commission concerning casing leaks in the Hobbs Pool, a temperature survey was run on the subject well and a leak was found at approximately 370'.

It is proposed to squeeze off the leak and also in an attempt to reduce gas-oil ratio and increase production, permission is requested to deepen well from present depth of 4217' to a total depth of 4277' and cement 350' of 5" OD liner on bottom. The liner will be perforated in the possible productive intervals as indicated by radio-activity survey.

A subsequent report will be filed upon completion of the above work.
