DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

To retest for production casing leaks for Commission

Bled 9-5/8" casing pressure from 110 to 50 psi in 3 minutes while 7" casing pressure remained constant at 190 psi. Flowed oil from 9-5/8" at 50 psi for 20 minutes with pressure constant. At increase flowing rate, 9-5/8" pressure gradually increased to 80 psi in 40 minutes with no change in 7" pressure. 30 minute SICP on 9-5/8" = 110 psi. No leak indicated.
