DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

To retest for production casing leaks for Commission

Intermediate casing pressure = 480 psi, oil string = 670 psi. Bled intermediate to 0 in 3 minutes with small flow of salt water in first 45 seconds. Oil string declined to 600 psi. Closed intermediate and oil string 2 hours. Intermediate pressure built up to 25 psi. Oil string 620 psi. No leaks apparent.
