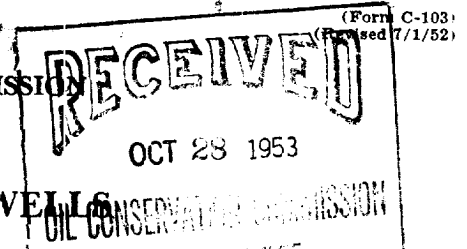

Spotted 5 sack cement plug in top of 8-5/8" casing from 16' to surface and erected 4" marker as required by Rule 202. Well PLUGGED & ABANDONED 10-24-53.
