Gentlemen:

A request is hereby submitted for a waiver of the unorthodox location of Shell State A-1, a gas well in the Byers-Queen Pool of Lea County, New Mexico. State A-1 was completed in June 1930 as a San Andres (Hobbs pay) oil well and with the advent of 40-acre spacing was plugged-back and recompleted as a Queen (Byers pay) dry gas well.

State A-1 is located 2310 feet from the north line and 1650 feet from the east line of Section 32, Township 18 South, Range 38 East. At this location the well is nearer than 660 feet (the legal distance specified in Rule 3, Case No. 590, Order No. R-376-A) from the boundary of the northwest one-quarter of Section 32 and is not closer than 1320 feet (the legal distance specified in Rule 3) to any other Byers-Queen gas well. A plat showing the location of this well has already been submitted.

A copy of this letter is being mailed to all operators within a 1320-foot radius of State A-1 as notification of this request for waiver.
