

It should be signed and sworn to before a notary public for reports on beginning drilling operations, results of shooting well, results of test of casing shut-offs, result of plugging of well, and other important operations, even though the work was witnessed by an agent of the commission. Reports on minor operations need not be signed and sworn to before a notary public. See additional instructions in the Rules and Regulations of the Commission.

Set Lane-Wells Bridging Plug in 7" casing at 3750'. Bailed hole dry. No fluid entered hole. Perforated casing with 56 shots from 3621 to 3685'. On open flow test well produced sweet gas at the rate of 6,500 MCF per day. Maximum shut in pressure 1600 pounds. Well now shut in.
