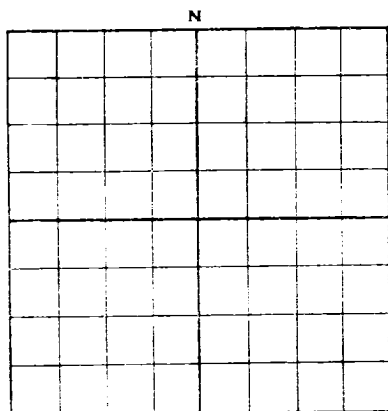
**NOTICE OF INTENTION TO DRILL NEW WELL**
