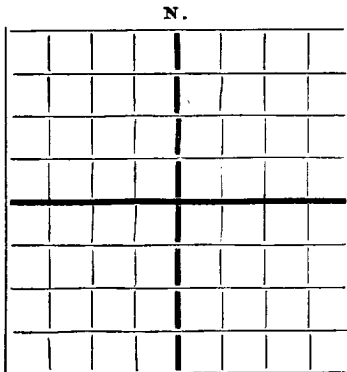

## NOTICE OF INTENTION TO DRILL NEW WELL

Notice must be given to the State Geologist or to the proper Oil and Gas Inspector and approval obtained before drilling begins. If changes in the proposed plan are considered advisable a copy of this notice showing such changes will be returned to the sender. Submit this notice in triplicate. One copy will be returned following approval.

Dear Sir: You are hereby notified that it is our intention to commence the drilling of a well to be known as **B H Turner** Well No. **2** in **NW 1 NE 1** of Sec. **34** T. **18S**, R. **38E**, N. M. P. M., **Hobbs** Oil Field **Lea** County

The elevation of the derrick floor above sea level is **3640** feet. We propose to drill well with No. **Rotary**

Make of Drill

We propose to use the following strings of casing and to land or cement them as indicated.

If changes in the above plan become advisable we will notify you before cementing or landing casing. We estimate that the first productive oil or gas sand should occur at a depth of about **4180** feet.

Additional information: **This location is 330' East of west property Line and 300' north of South Unit Line. The footage is forced by reason that the well is located in a thickly settled portion of the Hobbs Town site.**

**Also the well is located on the extreme edge of the field. Therefore, to avoid as much surface obstruction as possible and still be reasonably sure of a producing well, the footage given is necessary.**
