DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This well would swab but 4 bbls per hour thru 2 $\frac{1}{2}$ " tubing from a depth of 4226. Two acid treatments of 2000 and 1000 gallons respectively had no effect on the production. The well was then deepened to 4241 and acidized in three stages of 1000, 2000, and 6000 gallons each. All treatments were w/hot acid. The result was to increase the production from 96 bbls oil per day swabbing to 1620 bbls oil per day flowing thru open 2 $\frac{1}{2}$ " tbg.
