A retrievable bridge plug set in 5½" casing at 8630' to temporary abandon present producing perforations at 8644-8781' in the Abo Reef zone. An additional interval in Abo Reef zone from 8494-8620' was perforated with 22 jet shots. These perforations treated with 1200 gallon MCA acid followed by 5000 gallon CRA acid. Well returned to production.
