Gentlemen:

Reference is made to your letter of April 24, 1963, wherein you request authority to complete your State of New Mexico "R" Well No. 6, located 2310 feet from the North line and 760 feet from the East line of Section 6, Township 18 South, Range 35 East, Lea County, New Mexico, as a tubingless completion in the Vacuum Abo Reef Pool. It is our understanding that the production casing string will consist of approximately 8850 feet of 2 7/8-inch tubing cemented in a 7 5/8-inch hole.

Inasmuch as corrosion is not expected to be a problem in this area and that adequate measures will be taken to counteract the expected paraffin accumulation, the aforesaid completion is hereby authorized.
