We propose to do the following work on subject well:

1. Perforate 2 7/8" O. D. Casing with one jet shot at 8556', 8562', 8570', 8581', 8587', 8595', 8602', 8609', 8614', and 8621'.
2. Set retrievable bridge plug at 8680', and dump sand on plug.
3. Acidize with 2000 gals 15% NE acid in 10 equal stages with ball sealers between each stage. Pump 20 bbls of lease crude, follow with 10,000 gals 15% chemically retarded acid in two 5000 gal stages with ball sealers between stages.
4. Swab well, recover load oil, Test, place well on production.
