Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled out below 8-5/8" casing string set at 1750' with 8" cable tools. On 4-3-63, 4-1/2" OD 9.5# J-55 casing was run and set at 4400' with 120 sx. Inconel cement. Tested casing with 2500 PSI for 30 minutes with no loss in pressure. Pulled cave string. After WOC 18 hours; perforated casing 4332'-4354' w/2 SPF. Acidized with 500 gallons S-O-F with 20,000 gal oil and 40,000# sand. Never recovered load. Dry hole. We propose to plug and abandon as follows: Spot 25 sx cement plug over perforations 4332-54'. Cut and pull 4-1/2" casing from approx 3320'. Spot 25 sx. plugs half in and out of 4-1/2" stub at 3320', 1850' and 334', spot 10 sx plug at surface and erect PXA marker. Clean, level and restore ground to its natural contour.
