DETAILS OF WORK

We propose to drill Shell Middleton-Federal "B" Well No. 1 as a 11,300' Pennsylvanian test w/Rotary Tools as follows:

Drill 17' hole to 830', cement 48#, 13 3/8" casing w/850 sx. Circulate cement.
Drill 11' hole to 3700', cement 32#, 8 5/8" casing w/1100 sx. Circulate cement.
Drill 7 7/8' hole to 11,300', cement 15.5#, 17#, 5 1/2" casing w/600 sx.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
