String No. 2: Ran 10,215' of 2-7/8" O.D. casing (6.4 - New) and set at 10,226'. String No. 3: Ran 9462' of 2-7/8" O.D. casing (6.4 - New) and set at 9473'. Set bull plug at 9473'.

Cement down strings 1 and 2 with 1750 sacks of Class "C" 4% Gel plus 500 sacks of Class "C" with friction reducing agent. Pump plugs down with 1000 gallons of acetic acid. Cement circulated. Job complete 6:45 A.M. August 21, 1963.

Tested 2-7/8" O.D. casing with 1000 psi for 30 minutes from 6:00 to 6:30 A.M. August 22, 1963. Tested O.K. Drilled plugs and retested for 30 minutes from 8:00 to 8:30 A.M. August 22, 1963. Tested OK. Job complete 8:30 A.M. August 22, 1963.
