We plan to plug the well as follows: Set 10 sack cement plug at 9470 to 9370 feet; cut and pull 4 1/2" casing from 3000 feet; set 35 sack cement plug at 3000 to 7850 feet; 25 sack cement plug from 5850 to 5750 feet; 25 sack cement plug at 5200 to 5100 feet; cut and pull 9 5/8" casing from 3100 feet; set 25 sack cement plug from 3150 to 3050 feet; set 25 sack cement plug from 1750 to 1650 feet; 25 sack cement plug from 450 to 350 feet and 10 sack cement plug at surface.
