Drilled out the cement and pressure tested the casing to 1500 psi and held. Went in the hole and retrieved the RBP at 5561' and pulled out of the hole with the tubing and RBP. Ran in the hole with the 2 3/8" production string, tubing anchor, and seating nipple. Landed the tubing at 6194'. Ran in the hole with rod pump and rods and started the well pumping to the battery.
