Gentlemen:

Reference is made to your letter dated March 17, 1964, wherein you request authority to complete your State of New Mexico "L" Well No. 7 located in Unit A of Section 1, Township 18 South, Range 34 East, as a single tubingless completion in the Vacuum (Glorieta) Pool, Lea County, New Mexico.

It is our understanding that the production casing string will consist of 2 7/8-inch tubing set at approximately 6750 feet with perforations from approximately 6100 feet to 6120 feet.

The Oil Conservation Commission hereby approves the aforesaid tubingless completion, provided that sufficient cement shall be used on the 2 7/8-inch casing to bring the top of the cement up into the intermediate casing string.
