TEXACO Inc. respectfully requests administrative approval of an exception to New Mexico Oil Conservation Commission Fule 107 (e) for its State of New Mexico "AC" (NCT-1) Well No. 9. This well is a proposed single tubingless completion in the Vacuum (Abo Reef) Pool, and is located 330 feet from the south line and 2100 feet from the west line of Section 2, T-18-S, H-34-E, Lea County, New Mexico.

The production casing string will consist of $2-7/3^{\rm H}$ 0. D. tubing set at approximately 9050 feet in a 7-5/3 inch hole. Completion will be through perforations from approximately 3900 feet to 9000 feet in the Abo Reef formation. The well is expected to flow and no corrosion has been encountered. Paraffin deposition has occurred in the top 2000 feet, for which the casing shall be plastic coated to resist paraffin deposition.

This zone has been approved by the New Mexico Oil Conservation Commission as a tubingless completion in other single completions in this area. An instance is TEXACO Inc.'s State of New Mexico "AE" Well No. 19.

Attached is a diagrammatic sketch of the proposed tubingless completion and a plat showing the location of all wells on the State of New Mexico "AC" (NCT-1) Lease and all offset wells along with the name and address of all offset operators.
