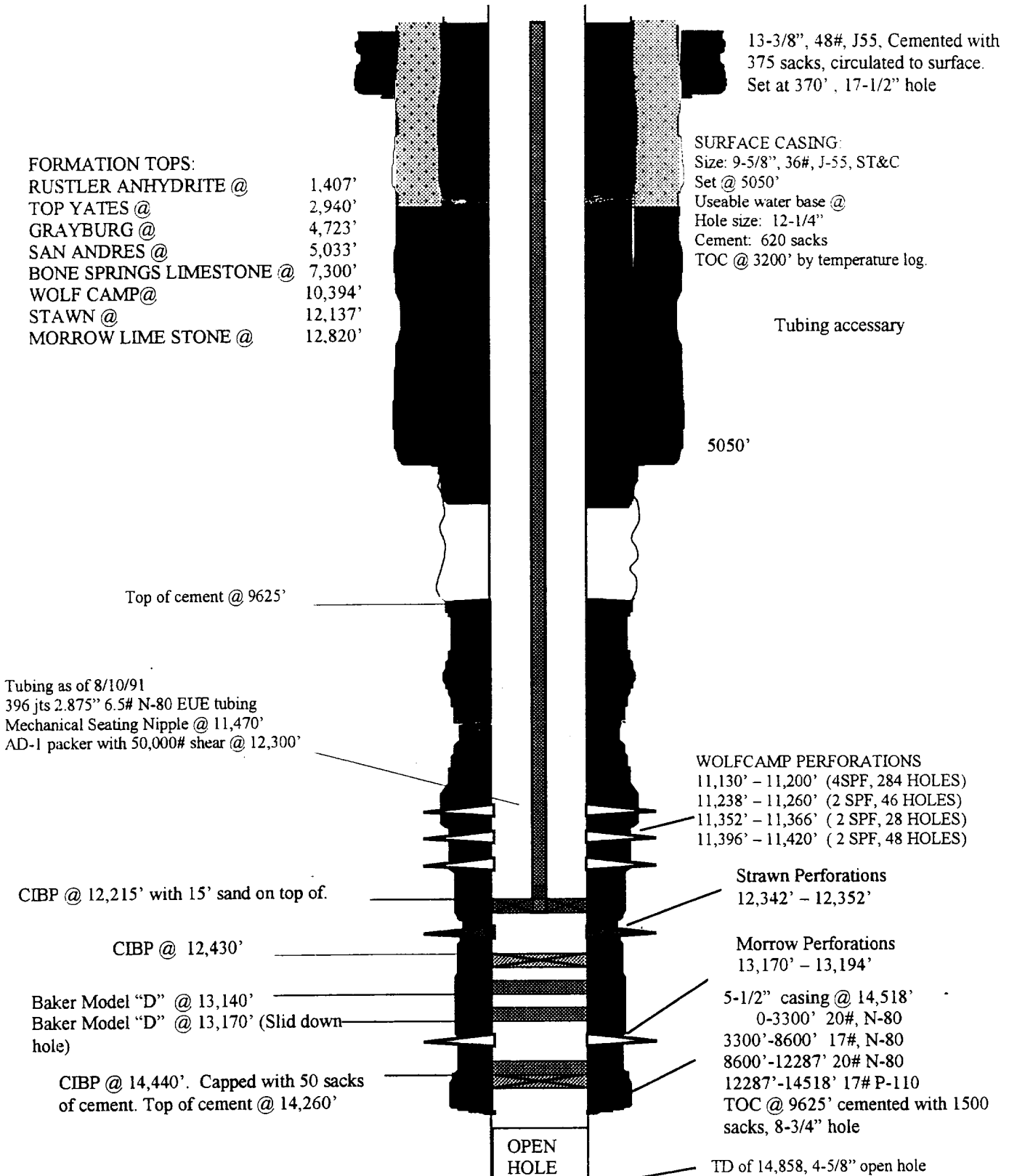

DRILL OUT CIBP SET AT 12,215' AND OPEN UP THE EXITING STRAWN PERFS 12,342'-12,352'. RUN 2-3/8" TBG AND AD-1 PKR AND SET AT 12,300'. ACIDIZE STRAWN PERFS 12,342'-12,352' W/2000 GLS 15% NEFE ACID.

THE WOLFCAMP PERFS 11,130' - 11,420' WILL BE NON PRODUCTIVE AND ISOLATED BY THE PACKER. THE STRAWN PERFS 12,342'-12,352', WILL PRODUCED BELOW THE PACKER THROUGH THE 2-3/8" TUBING. SEE ATTACHED CURRENT AND PROPOSED WELLBORE SKETCHES.

A SEPARATE SUNDRY IS BEING FILED TO AMEND CURRENT SURFACE COMMINGLING PERMIT FOR THE UNCLE FEDERAL NO. 3 TANK BATTERY TO ADD THE SOUTH CORBIN STRAWN POOL

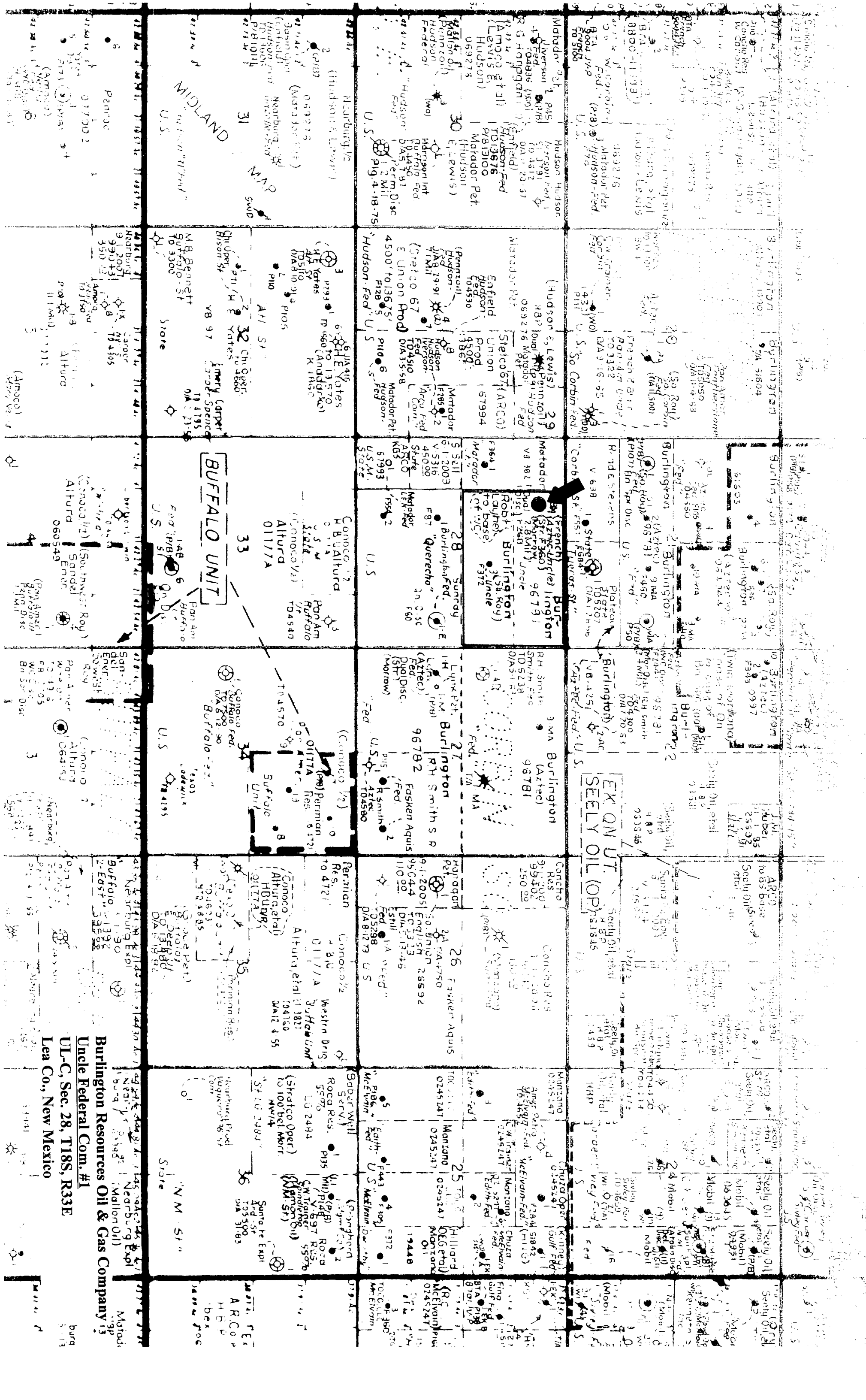
