O.T.D. 8790' Dolomite, PBTD 4698'. MIRU a completion unit and POOH w/tubing, rods and BHP. RIH w/4-1/2" CIBP on WL and set the CIBP @ 4720' and dumped 2 sacks on top @ 4720 - 4698', blanking off the old Grayburg Perfs @ 4730 - 4756'. Perforated the Upper Grayburg w/32 holes (0.36" dia & 7.82" pen in Berea) @ 4668 - 4684'. RIH w/2-7/8" tubing and packer and set the packer @ 4555'. Swabbed -0- BO + 26 BLW/1 hr. and swabbed dry. Acidized thru Grayburg Perfs @ 4668 - 4684' w/2250 gals 15% NeFe HCl acid. Max press 4600#, min press 1770#, 5 min SIP 1360#, 10 min SIP 1210#, 15 min SIP 1100#. Swabbed -0- BO + 20 BW/3 hrs. and swabbed dry. Fraced thru Grayburg Perfs @ 4668 - 4684' w/ 16,175 gals crosslinked gelled 2% KCL water (40# system) + 40,000# 20/40 sand. Max press 4600#, min press 3640#, ATP 4000#, AIR 18.5 BPM, ISIP 3000#, 5 min SIP 2200#, 10 min SIP 2200#, 15 min SIP 2170#. 68 hr. SITP 0#. Swabbed -0- BO + 77 BLW/11 hrs. POOH w/2-7/8" tubing and packer set @ 4555'. RIH w/2-3/8" tubing and set the tubing @ 4631'. Ran rods and BHP and put the well on the pump. Pumped -0- BO + 3 BW/24 hrs. POOH w/2-3/8" tubing, rods and BHP. After receiving approval from the BLM @ Carlsbad, New Mexico this well was plugged and abandoned in the following manner:

1. RIH w/4-1/2" CIBP and set the CIBP @ 4630' and dumped 2 sacks of cement on top of the CIBP @ 4630 - 4601', blanking off the Grayburg Perfs @ 4668 - 4684'.
2. RIH w/2-3/8" OE'd tubing to 4585' and tested the casing to 1000# and loaded the hole w/9.5 ppg mud laden fluid. Spotted a 10 sack (Continued on attached

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
