We propose to drill a well at the above location to approximately 4700 feet to test Penrose Formation. Will drill surface hole of 12 1/4" and set 8 5/8" surface casing at 250'

If well is indicated productive we will set 5 1/2" or 4 1/2" oil string to 4700'. Cement w/125 ax. 8% gel or sufficient amount of cement to cover base of salt. Run electric log. Perforate and frac pay zone if necessary.

This application supersedes previous one on this well submitted December 27, 1966 and approved by your office December 29, 1966. Reason for moving location to drill in a more favorable part of our acreage.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.
