Gentlemen:

Temporary special rules were established by Division Order R-8181-B for the South Corbin Wolfcamp Pool effective May 20, 1986. You were advised of this by our letter of June 10, 1986. This letter also requested that you submit a revised C-102 dedicating 80 acres to your Hudson 29 Federal #1-B in Sec 29, T18S, R33E.

This order allowed 60 days for you to comply with this provision and as of this date we have not received a revised Form C-102 for this well. Unless we have received a plat dedicating 80 acres to this well by August 8, 1986, your allowable will be reduced to one-half of a standard allowable. If you do not have 80 acres to dedicate, you will need to obtain approval of a non-standard proration unit.

SUBJECT: Division Order No. R-8181-B

Gentlemen:

According to the provisions of Division Order No. R-8181-B, effective May 20, 1986, temporary special rules have been assigned to the South Corbin-Wolfcamp Pool.

They include:

80 Acre spacing, with new wells to be located within 150 feet of center of any quarter/quarter section. Standard proration unit to consist of S/2, N/2, W/2, or E/2 of any quarter section.

A depth bracket allowable of 445 barrels of oil per day for a standard proration unit is assigned to this pool.

Please submit new Form C-102 assigning a standard 80 acre proration to your Hudson 29 Federal Well No. 1 located in Unit B of Section 29, Township 18 South, Range 33 East.
