- 9-1-68 After 19 hrs WOC, tested csg. w/1,000# for 30 min - O.K.
- 9-7-68 Drilled 11" hole to 4312' - Ran 8 5/8", 24# & 32# csg. to 4312'. Cement w/340 sx Class "H" 50/50 posmix 6% gel w/ 31# salt per sack plus 150 Sx Class "C" w/8# salt per sack. Plug down at 4:15 P.M. - Ran temperature survey. - Top cement 2970'.
