Well was plugged and abandoned as follows:

1. Tagged bottom w/ 2-3/8" tubing at 5060'. Spotted 25 sx. cement plug from 5060-4845' (est.).
2. Circulated hole w/Mud Laden Fluid. Run Hyd. Jacks.
3. Cut casing at 3443', could not pull.
4. Cut casing at 3107', could not pull. Spotted 25 sx. cement plug from 3147-2932'.
5. Cut casing at 2550', could not pull.
6. Cut casing at 1998' and pulled out of hole.
7. Ran tubing to 2057' and spotted 25 sx. cement plug from 2057'-1935'.
8. Spotted 25 sx cement plug 50' below 8-5/8" casing shoe at 353'.
9. Installed Dry Hole Marker and leveled location.
