Well is currently completed in the Drinkard formation with perforations from 6652 - 6929. Texland plans to plug back to Blinebry formation. Run 7" CIBP and set at 6120' and cap with 20' cement. Perforate selection per log - overall interval to be 5740' - 5970' pick up 2 7/8" tubing and packer. Acidize new perfs with 3500 gals 15% HCl and ball sealers. NOTE: previous perfs 5882-98, 5903-07, 5910-14, 5918-39 were cement squeezed. Swab back load to clean up and evaluate. PTG and PKR Return to production with 2 7/8" tubing, 76 rod string and 1 1/2" pump.
