Then, cemented 4,776' of 4-1/2" 9.5#/ft. MSO casing with float valve 1 jt. above guide shoe at 4,765' with 350 sx. HOWCO Lite Water cement plus 200 sx. Incor containing 2% gel and 3% salt/sack. W.O.C. 150 hrs. Tested 30 minutes with 1,500 psi dropping to 1,400. - OK.
