- 8-19-71 Set Titan plug at 5350. Dump 20 feet of cement on top of plug. Perforate 4½ casing at 5144 to 5170 with 2 jet shots per foot, total of 52 shots.
- 8-24-71 Ran 164 fts. (5182 ft.) of 2 7/8" tubing. Acidize well with 1000 gallons of 15% acid.
- 8-25-71 Pulled 164 fts of 2 7/8" tubing.
- 8-27-71 Acidized well with 5000 gallons of 15% acid.
- 9-1-71 Ran 5100 feet of 2 7/8" Duolined tubing.
- 9-7-71 Pumped 40 barrels of 52 gravity oil down casing. Tested well-Well taking 200 barrels of water per hour with 400 # casing pressure and 0 pressure on tubing.
